Prior to drafting any contract for goods or services, the responsible party or the decedent's survivor who is handling the funeral arrangements is entitled to receive a copy of any pre-need agreement, in the possession of the funeral establishment, that has been signed and paid for, in full or in part, by or on behalf of the decedent.

Payment Terms

Payment is due in full prior to services being rendered. We accept cash, zelle, check, VISA, Mastercard, Amex or Discover. There is a 3.0% convenience fee for all credit card transactions.

CREMATION PACKAGES

Direct Cremation (Simple Cremation)

Includes the basic services of a funeral director and staff, the removal of the decedent from a hospital, nursing home, or coroner's office (additional fees apply for residential and Board-and-Care removals), sheltering the decedent in our licensed climate-controlled area, alternative cremation container, private cremation, completion of the death certificate, disposition permit fee, Department of Consumer Affairs fee, all taxes, a temporary plastic urn and hand delivery within 10 miles of one of our offices (restrictions apply). Includes your choice of: fingerprints, photographs, or locks of hair (up to two of these items when your loved one is presentable).

Direct Cremation with Sea Scattering Package

Includes all basic services, private cremation and unwitnessed sea scattering with a sea scattering certificate.

Basic Cremation Package

Includes all basic services, transportation from residence or Board-and-Care, private cremation, and your choice of urn (\$100 value).

Witness Cremation Package 1 – Palm Springs

Includes all basic services, transportation from residence or Board-and-Care, preparation of your loved one (dressed or draped), one-hour viewing, witness cremation, and your choice of urn (\$100 value). Also includes same day, end-of-day pick-up of your loved one's ashes.
